



CONFERENCE REGISTRATION Terms and Conditions

The Terms and Conditions define the registration rules and regulation with regards to on-line conference participation in the "Future of Private Labels" conference held on 16 June 2016 in Targi Kielce SA (hereinafter referred to as TK) in Kielce and conditions for the Conference participation.

1. The Conference participation cost for one person the is:
 - **490,- PLN + 23% VAT -THE TIME-LIMITED OFFER - only the first 100 registrations** made no later than 20 May 2016 (promotional price is a subject to availability). Full amount payment is required no later than 7 after the date of registration.
 - **750,- PLN + 23% VAT** – after THE TIME-LIMITED OFFER is no longer available and/or the registration is made after 20 May 2016.
2. This price includes: lectures, the "Get-Together" gala ceremony and the evening banquet participation, conference materials, coffee breaks.
3. The Ordering Party (participant that registers for the Conference), by filling in and submitting the conference registration form, whose template is available at the www.markiwasne.pl website enters a binding agreement between the with TK. By filling in and submitting the conference registration form the Ordering Party agrees to observe all rights and liabilities arising from the Terms and Conditions. The participant that has registered for the conference will be notified via e-mail communication. A confirmation which contains all the essential elements of the Agreement is sent to the e-mail address indicated in the registration form.
4. Pro-forma invoice will be issued and sent within 2 business days after receipt of a completed registration form to the e-mail of the participant's accounting department or another e-mail address indicated in the application form at the participant's discretion.
5. The person that has completed the registration form on behalf of the conference participant hereby declares that has been authorized to duly represent and act on behalf of and for the benefit of the participant and in particular to a enter a binding agreement with TK.
6. Payment should be made within 7 days after the e-mail receipt, as stipulated in section 6 of this Terms and Conditions, however no later than 4 working days before the Conference commencement date.

9. In the case of registrations made before 20 May 2016, a cost-free cancellation may be made until 30 May 2016. At the same time the Organizer assumes the obligation to send participants of the conference the conference agenda no later than 20 May 2016.
10. In case of cancellation filed after 30 May 2016, the participant is obligated to pay the processing fee of 250 PLN + 23% VAT for each cancellation. For participants delegated by retailers the processing fee is 150 PLN + 23% VAT for each registration cancelled.
11. In the case of a participant's absence in the Conference without a prior written cancellation, the participant is obligated to pay the full participation fee as stipulated in the Agreement.
12. No payment shall not be deemed a waiver of the Conference participation.
13. Another person indicated by the Participant may participate in the Conference in place of the person originally registered to take part in the Conference.
